 - 1. Consideration of a motion to Rescind the prior resolution passed on March 6th, 2017 relating to the Isabella County Road Commission contact for the 2017 Gravel Road Brine Program. Said resolution was valued in the amount of \$11,299.73. that was an error and that value should be replaced with a value of \$12,548.49. Motion made my B.  - 2. Consideration of a motion to Rescind the prior resolution passed on March 6th, 2017 relating to the Isabella County road commission contract for the 2017 ICRC Graveling Program. Said resolution was valued in the amount of \$45,000. The final contracts came in with a total value of \$57,347.57. Motion made by L. Cole for the consideration and seconded by S. Allen. Consideration of a resolution to enter into a Franchise Service Agreement with Tri-County electric for a period of 30 years, renewing a prior contract executed on April 3, 1989 by the Vernon township Board.  - 4. Consideration of a motion to accept a quote for the reroofing of the Township Hall. Motion by B. Browning to accept the bid from Integral Builders for contract #14656. The color to be determined by Ben and the addition of snow bars to the south side of the roof and for them to check the condition of the cupola as well as the entry door roof and to check the sheeting. Motion seconded by M. Turner. Motion passed 4-1.
