**WHEREAS**, MCL 168.778(a) provides the Election Commission or their authorized assistants, shall inspect the voting machine to determine whether it is properly prepared; and

**WHEREAS**, that any authorized assistant shall not be the same person who prepared and set the voting machine; and

**WHEREAS**, the Election Commissioners or their authorized assistant shall prepare and file with the Commissioners a written certificate certifying to the correct adjustment of the machine, the number of the machine, whether or not all the candidates and question counters and the public counter are set at zero, the number registered on the protective counter, if one is provided, and the number of the metal seal with which the machine is sealed; and

**WHEREAS**, such certification shall be held at a Public Accuracy Test on \_\_\_\_\_, 2016 at the Isabella County Building, and

**WHEREAS**, said Act authorizes Election Commissioners who may not be able to attend to appoint an assistant to act in the capacity of an Election Commissioner; then
