Consideration of a 2017 application for Fireworks Other than Consumer or Low Impact permit by Robert Denton and the Michigan Pyrotechnics Arts Guild, for display of fireworks in relation to its activities on May 20th, 2017. Per state law, the local municipality is the agency authorized to approve such permits. Motion by S. Allen to allow the display of fireworks. Motion seconded by M. Turner. Motion passed.
- 3. Consideration to join with Isabella Township and the ICRC to participate in an experimental paving job on the mile of Vernon Road, between Isabella and Summerton Roads for a sum not to exceed \$20,000 to Vernon Township. S. Allen made the motion. Motion failed for second.
- B. Browning made a motion to deny the participation of the read project with Isabella Township. L. Cole seconded the motion. Motion passed 3 to 2.
- K. Adjournment. S. Allen made the motion to adjourn. B. Browning seconded the motion. Motion passed. This meeting was adjourned at 7:30 p.m.
