Resolution: Resolution No. ০০০ - ২০০৭: Resolution Withdraw Resolution No. 008-2018 and to Provide a 2019 Road Funding Grant to the Isabella County Road Commission (ICRC).

WHEREAS, Vernon Township adopted a resolution to provide Grant Funding for the Wedge Paving of (4) miles of Stevenson Lake Road, Resolution No. 008-2018 on October 1, 2018, and

WHEREAS, the ICRC has since revised its proposed Stevenson Lake Road improvements to a 2.0 inch on average overlay which increases the cost of the improvements, and

WHEREAS, the ICRC has asked Vernon Township for new Grant Funding to provide dust control to 40.61 miles of gravel roadways, improve (2) miles of gravel roadbeds within the Township and to improve roadways in the Vernon Hill area, and

WHEREAS, the ICRC estimates it will cost in excess of \$403,000 to complete the Stevenson Lake Road improvements, \$16,954.68 for dust control, \$36,000 to improve the (2) miles of gravel roadbeds and an as yet to be determined amount to improve Vernon Hill area roads, and

WHEREAS, In spite of the fact that the maintenance of roadways in Vernon Township are the legislated responsibility of the ICRC; Vernon Township is interested in seeing improvements to the specific area and has heard concerns of Township citizens and taxpayers as to the condition of said roadways, then

BE IT RESOLVED, that the Vernon Township will provide 2019 Grant Funding to the ICRC of twenty one percent (21%) of the Stevenson Lake Road improvement cost with a not to exceed maximum of \$85,000, \$13,563.74 for dust control, \$18,000 for the two (2) miles of gravel roadbeds improvements and an amount not to exceed \$20,000, towards improvements to Vernon Hill roads. Vernon Township's allocation of Grant Funding as noted above is to be considered an accommodation to the ICRC request of Vernon Township and in no way shall infer or establish that Vernon Township and the Vernon Township Board has any authority or responsibility for the maintenance and construction of roadways in Vernon Township.

BE IT FURTHER RESOLVED, that this resolution is properly adopted by the Vernon Township Board at its regular monthly Board Meeting held on this 1st day April, 2019.
