

**VERNON TOWNSHIP
ISABELLA COUNTY, MICHIGAN**

Resolution: Resolution No. 003 -2020: Resolution to Participate with the Isabella County Road Commission (ICRC) for the 2020 ICRC Gravel Program in the Township of Vernon.

WHEREAS, the ICRC has asked Vernon Township to financially participate in its 2020 Gravel Program, and

WHEREAS, the ICRC Gravel Program will provide \$16,990.30 plus contingency fee of \$1,699.06 to gravel one mile and asks Vernon Township to provide \$16,990.30 plus contingency of \$1,699.06 for a second mile, and

WHEREAS, In spite of the fact that the maintenance of roadways in Vernon Township are the legislated responsibility of the ICRC; Vernon Township will contribute the requested \$16,990.30 plus contingency fee of \$1,699.06 as a grant to the ICRC, allocated across 2 full miles of Isabella Road below and in addition shall contribute an additional \$72,201.79 to the remaining roads listed below for a total 2020 Gravel Program Grant of \$90,891.11, then

BE IT RESOLVED, that the Vernon Township Board authorizes the granting of funding to the ICRC to be credited towards the 2020 Gravel Program for use on the following roadways:
